

**SILVER SALMON CAMP**  
**ASSUMPTION OF RISK, RELEASE OF LIABILITY, AND WAIVER OF**  
**CLAIMS**

The Silver Salmon Camp (“Camp” or “the Camp”) is owned by Southcentral Foundation (“Owner”) and is operated by the Nudlaghi Leadership Institute (“Institute”). I am voluntarily signing this Assumption of Risk, Release of Liability, and Waiver of Claims (the “Agreement”) in exchange for attending Camp, participating in Camp activities, and using the Camp’s facilities. I acknowledge that I am attending Camp, participating in Camp, and using the Camp’s facilities at the invitation of the Owner and/or the Institute.

**1. Inherent Risks Associated with Attending Camp and Using Camp Facilities and Equipment in a Remote Location.**

I acknowledge and understand that the Camp is in a remote location and that there is a risk that I will only have access to limited medical care, if necessary, during my stay and, if I require rescue or medical treatment, it may be delayed due to the location of the Camp and/or weather conditions. I acknowledge and understand that the Camp will make its facilities and equipment available for my use, and that I may face risks associated with defects or conditions in the Camp’s facilities, including bunk houses, bathroom facilities, and saunas, and the Camp’s equipment, including outdoor recreational vehicles (ORVs), and helmets. I acknowledge and understand that I will have the opportunity to participate in outdoor activities while at the Camp, including fishing, hiking, swimming, riding ORVs, and watching wildlife, and that there may be inherent risks to my health and safety that are associated with these activities, including but not limited to inclement weather, rough and remote terrain, and dangerous and aggressive wildlife. I acknowledge and understand that the risks associated with these activities include bodily injuries caused by slips, trips, falls, ORV accidents, and encounters with wildlife, hypothermia and, possibly, death, all of which can impair my enjoyment of life, ability to earn a living, and ability to participate in a range of activities. I understand that these risks may exceed the accepted safety of my life at home or in my normal day to day activities, and that those risks contribute to my enjoyment of such activities. I understand that such risks cannot be eliminated from these activities and acknowledge that I am choosing to participate in these activities regardless of these risks. I acknowledge and understand that I am ultimately responsible for my own safety while attending Camp and using the Camp’s facilities and participating in activities at Camp, and that failing to use or properly use equipment provided to me by the Camp may increase my risk of injury or of not surviving an accident or incident that occurs while I am attending Camp and participating in these activities.

**2. Express Assumption of All Risks Associated with the Camp and Camp Activities.** I understand and assume all inherent risks, known and unknown, that are or may be associated with attending the Camp, using the Camp’s facilities and equipment, and participating in the Camp’s activities. Despite these inherent risks, I am voluntarily attending the Camp, will voluntarily use the Camp’s facilities and equipment, and will voluntarily participate in Camp activities. I understand that attending Camp and participating in the Camp’s activities can involve a range of risks, only some of which are outlined above. I acknowledge and understand that injuries I may sustain while at Camp, and any defects or conditions in the Camp’s facilities or equipment,

may be the result of the Camp's negligent acts or omissions in administering the Camp and maintaining those facilities or that equipment.

**3. Release and Waiver of All Claims, Including Claims of NEGLIGENCE.**

In consideration for attending the Camp, using the Camp's facilities and equipment, and participating in the Camp's activities, I hereby voluntarily release, forever discharge, waive and agree to indemnify and hold the Institute, the Owner, and their respective agents, owners, members, managers, officers, parent and subsidiary organizations or entities, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf harmless from any and all claims, demands, causes of action, liability, or injuries, including death, which may arise in connection with my attending Camp, participating in Camp activities, and using the Camp's facilities and equipment. It is my intent to release all liability, **including any claims which arise out of or allege negligent acts or omissions** of the Institute, the Owner, or their respective agents, owners, members, managers, officers, parent and subsidiary organizations or entities, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf. I also waive any claims I might have for breach of contract or warranty for statements or representations made outside of this Agreement.

**4. Forum Selection.** I agree that any dispute concerning this agreement, my attendance at Camp, or my participation in the Camp's activities will be governed by Alaska law and will occur in the Superior Court of the Third Judicial District in Anchorage, Alaska.

**5. Miscellaneous.** I agree that this agreement is intended to be interpreted as broadly as possible, and that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect. I understand that this document constitutes the entire Agreement between myself, the Institute, and the Owner. I further agree that this Agreement can only be modified in writing signed by both myself, the Institute, and the Owner, and that it cannot be modified by any written or oral representations or statements made outside of this document.

I AM 18 YEARS OLD OR OLDER. I HAVE READ ALL TWO PAGES OF THIS AGREEMENT AND UNDERSTAND AND ACCEPT THE TERMS AND CONDITIONS OF THIS ASSUMPTION/RELEASE/WAIVER. THIS AGREEMENT IS BINDING ON ME AND MY SUCCESSORS AND ASSIGNS. I UNDERSTAND THAT THIS RELEASE WAIVES AND RELEASES MY PROSPECTIVE CLAIM(S) FOR NEGLIGENCE AGAINST THE INSTITUTE AND THE OWNER.
